- (i) All nominations must be completed and signed using this prescribed Nomination Paper.
- (ii) All members of the Council must be of sound mind, in good physical health, in good financial standing and of good character.
- (iii) Members nominated to Council elections shall be citizens or ordinarily resident in Trinidad and Tobago at least 18 years of age and in good financial standing before the National Trust for a minimum period of one calendar year prior to nomination.
- (iv) This Nomination Paper shall be signed by not less than five financial members of the Trust, in addition to the Nominee, and shall be left with the Secretary on a date appointed by Council with notice not less than twenty-one calendar days provided to the membership.
- (v) Elected members to Council serve a term of three years and shall be subject to the provisions of the National Trust of Trinidad & Tobago Act, Ch. 40:53.
- (vi) Elected members are also subject to the Integrity in Public Life Act, Ch. 22:01 and are to submit annual declarations as required by the Integrity Commission of Trinidad and Tobago. For further information kindly consult <https://integritycommission.org.tt>.
